Question: WHERE IS FLOURISH RESIDENCE ELUJU LOCATED?

Answer: Flourish Residences is located at Eluju Town By Bogije, Lekki, Lagos State, Nigeria.

Question: WHO ARE THE OWNERS/DEVELOPERS OF FLOURISH RESIDENCES ELUJU?

Answer: REVOLUTIONPLUS PROPERTY DEVELOPMENT COMPANY LIMITED.

Question: WHAT TYPE OF TITLE DOES FLOURISH RESIDENCES ELUJU HAVE ON THE HOUSE?

Answer: Excision And Registered Survey

Question: ARE THERE ANY ENCUMBRANCES ON THE HOUSE?

Answer: The Land is free from government acquisition and adverse claim.

Question: WHAT IS THE PAYMENT STRUCTURE?
