**Question: WHERE IS ROYAL HAVEN GARDEN LOCATED?**

**Answer:** ROYAL HAVEN GARDEN is located at Oke-Orilemo By Mowe-Ofada, Ogun State, Nigeria.

**Question: WHO ARE THE OWNERS/DEVELOPERS OF ROYAL HAVEN GARDEN, MOWE-OFADA?**

**Answer:** REVOLUTIONPLUS CONSTRUCTION AND INFRASTRUCTURE COMPANY LIMITED.

**Question: WHAT TYPE OF TITLE DOES ROYAL HAVEN GARDEN, MOWE-OFADA HAVE ON THE HOUSE?**

**Answer:** C of O (In Process) Govt. approved Layout and Survey

**Question: ARE THERE ANY ENCUMBRANCES ON THE HOUSE?**

**Answer:** The Houses are free from government acquisition and adverse claim. **Question: WHAT IS THE PAYMENT STRUCTURE?**

**Answer:** Specific amount stipulated to be paid monthly after the initial payment for 1,2 or 3 years.
